If the Company does not receive a duly completed and signed reply form from you (or any other response from you indicating that you object to receiving corporate communications in electronic form on the Company's website) on or before 11 November 2022, you will be deemed, until you inform the Company otherwise by reasonable notice in writing to the Hong Kong Share Registrar at the above address or by email to is-ecom@hk.tricorglobal.com, to have elected to receive all future corporate communications in electronic form on the Company's website instead of receiving them in printed form. In that event, when the Company makes a corporate communication, it will only send to you a notification that the corporate communication has been made available on the Company's website.
